# Regulations Amending the Special Economic Measures (Russia) Regulations

---

Whereas the Governor in Council is of the opinion that the actions of the Russian Federation constitute a grave breach of international peace and security that has resulted or is likely to result in a serious international crisis;

Therefore, Her Excellency the Governor General in Council, on the recommendation of the Minister of Foreign Affairs, pursuant to subsections 4(1)<sup>a</sup>, (1.1)<sup>b</sup>, (2) and (3) of the *Special Economic Measures Act*<sup>c</sup>, makes the annexed *Regulations Amending the Special Economic Measures (Russia) Regulations*.
